



ORDINANCE NO. 2013-O- 12

AN ORDINANCE TO AMEND CHAPTER 42, OFFENSES  
AGAINST PUBLIC PEACE, SAFETY AND MORALS,  
SECTION 42.03, WEAPONS, OF THE PALESTINE VILLAGE CODE

BE IT ORDAINED by the Board of Trustees of the Village of Palestine, Crawford County, Illinois, that CHAPTER 42, OFFENSES AGAINST PUBLIC PEACE, SAFETY AND MORALS, SECTION 42.03, WEAPONS of the Palestine Village Code be, and the same is hereby amended to be, in its entirety, as follows:

42.03 WEAPONS:

(a) A person who is not a Village officer, shall not, without lawful permit issued by the State of Illinois, carry about his person any concealed pistol, switchblade, razor, slingshot, metal knuckles or any other weapon or thing of deadly character.

(b) No person shall sell, give or transfer any such weapon described to any minor person.


(c) No person shall discharge a BB gun, pellet gun, bow and arrow, crossbow, or any other object or device which propels a projectile which can cause damage to property and injury or death to an animal or person.

Any person violating any provision of this Ordinance, or any rule or regulation adopted or issued in pursuance thereof, shall upon conviction be subject to a fine of not less than \$50.00, nor more than \$750.00, and the costs of prosecution.

This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
