AN ORDINANCE ANNEXING CERTAIN TERRITORY TO THE  
VILLAGE OF PALESTINE CRAWFORD COUNTY, ILLINOIS

WHEREAS, certain properties are bounded by the Village of Palestine, Crawford County, Illinois, but have never been annexed to said Village; and

WHEREAS, Leo E. Adams and Phyllis Adams, is the owner of said real estate and no electors reside thereon; and

WHEREAS, Leo E. Adams and Phyllis Adams, have filed a PETITION FOR ANNEXATION of said territory to the Village of Palestine, Illinois; and

WHEREAS, it is determined to be in the best interest of the Village of Palestine, Illinois that territory be annexed thereto.

NOW, THEREFORE, BE IT ORDAINED by the Board of Trustees of the Village of Palestine, Crawford County, Illinois, as follows:

1. Beginning at a point 702.5 feet North of the Southeast Corner of the Southwest Quarter of Section 34, Township 7 North Range 11 West, Crawford County, Illinois, thence East 517.0 feet, thence South 132 feet, thence West 517.9 feet thence North 137 feet to the point of beginning, containing 1.56 acres, more or less. As per plat survey of Roger P. Henderson, Registered Illinois Land Surveyor No. 2101, dated June 20, 1986. as corrected June 30, 1986, and recorded in Cabinet C, Slide 428 in the Office of the Recorder of Crawford County, Illinois.

being indicated on a plat of the annexed territory which is appended to and made a part of the Ordinance, are hereby annexed to the Village of Palestine, Crawford County, Illinois.

2. That the Village Clerk is hereby directed to record with the Recorder of Deeds of Crawford County, Illinois, a certified copy of this Ordinance, together with the accurate map of the territory annexed.

3. This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
